Application method:

- · wheel or jetting applications on bookbinding machines

Recommended running temperature:

140 to 160 °C for labelling 160 to 180 °C for bookbinding (side glueing)

150 to 160 °C for bookbinding (end papering and joint application)

Cleaning

For the cleaning of melting tanks and application systems, we recommend the use of our HOTMELT CLEANER Q 1924.

For the cold cleaning of surface soilings on application equipment, conveyor belts or other machine parts, TECHNOMELT CLEANER MELT-O-CLEAN can be applied. TECHNOMELT CLEANER MELT-O-CLEAN is based on natural resources and facilitates manual cleaning even in case of pronounced charring. Before using TECHNOMELT CLEANER MELT-O-CLEAN, its suitability for lacquered and synthetic coated surfaces should be tested.
